We invite your kind attention to our letter No. SEC/2201/2016 dated 22<sup>nd</sup> January, 2016 vide which we have intimated the Exchange the result of E-voting and Postal Ballot in respect of following two Special Resolutions, which have been passed with requisite majority :

**Resolution No. 1 :**
